I understand the Grainger County Tomato Festival reserve the right to remove any vendors that they deem inappropriate to the Grainger County Tomato Festival. I acknowledge failure to comply with the standards of being "suitable for all ages" may result in my removal from the Grainger County Tomato Festival and jeopardize my participation in future Festivals. I understand that there are no refunds or rain checks due to inclement weather.
